

# LOW-INTEREST FINANCING FOR EFFICIENCY UPGRADES FOR HOMEOWNERS



## HOW TO APPLY

- 1** Make sure you're a homeowner in San Luis Valley REC's service territory. Our program only available to members.
- 2** Apply for a free, data-driven energy assessment of your project at: [www.slvrec.com/electrify-and-save](http://www.slvrec.com/electrify-and-save)
- 3** We will review your project application for program eligibility. If approved, we connect you with a contractor within our program.
- 4** Your contractor submits a project proposal to our portal, including desired measures and cost.
- 5** Once the project scope is approved, your contractor will begin work. No upfront payment is required.
- 6** Once work is completed, your repayment will appear on your monthly electric bill, no additional payment actions required.

Take advantage of San Luis Valley REC's (SLVREC) Electrify and Save on-bill repayment program (OBR) for a simple and transparent financing option.

- + NO MONEY DOWN, NO CREDIT CHECK, NO LOANS**  
Instead of a loan, payments are added to your monthly utility bill and can be repaid over one to ten years, with interest rates between 4% and 4.99%. Since there's no loan, your home upgrades won't affect your credit score or add to your debt.
- + SAVE ON HIGH EFFICIENCY UPGRADES**  
Make your home more comfortable while reducing your long-term energy bills. Upgrades include new insulation, windows and doors, water heaters, electric HVAC systems, electric vehicle chargers and more. Depending on the efficiency upgrades, the utility bill may even be less!

## HOW DOES MONTHLY REPAYMENT WORK?

SLVREC, through partnerships with wholesale power supplier Tri-State Generation and Transmission Association and the Colorado Clean Energy Fund (CCEF), is offering an on-bill repayment (OBR) program to residents or business owners to install certain energy upgrades to their property at no upfront cost. These upgrades are repaid via a voluntary tariff on their monthly utility bill. The term “repayment” denotes that a third party, in this case CCEF, provides the upfront funding for the installation. In turn, SLVREC will bill customers on a monthly basis to recover CCEF’s costs over an agreed-upon timeframe. In many cases the energy savings achieved through the newly installed measures is greater than the monthly repayment obligation, thereby saving customers money on their utility bill every month.

## ADDITIONAL REBATES AND INCENTIVES

- + **AIR-SOURCE HEAT PUMPS:**  
BASE TIER: \$250/ton, up to 5 tons and \$125/ton for capacity above 5 tons  
COLD CLIMATE: \$500/ton, up to 5 tons and \$250/ton for capacity above 5 tons
- + **HEAT PUMP WATER HEATERS:**  
\$350/unit for air source heat pump units
- + **MANAGED (SMART) EV CHARGERS:**

## UPGRADES INCLUDE BUT NOT LIMITED TO:

<b>Air sealing and insulation</b>
<b>Air-source heat pumps for space heating and cooling, including dual-fuel systems, mini-splits, and air-to-water</b>
<b>Battery storage*</b>
<b>Central air conditioning</b>
<b>Demand response equipment, including programmable thermostats</b>
<b>Electric thermal storage units</b>
<b>Electric vehicle chargers</b>
<b>Electric water heaters</b>
<b>Electrical panel upgrades</b>
<b>Energy recovery ventilators (ERV) or heat recovery ventilators (HRV)</b>
<b>Evaporative cooling</b>
<b>Ground-source heat pumps</b>
<b>LED lighting (must be part of larger project)</b>
<b>Storm or replacement windows and doors</b>
<b>Whole-home or attic fans</b>

To be eligible for on-bill repayment, upgrades must result in reduced utility costs, reduced greenhouse gas emissions, increased electrification, and/or increased renewable energy generation.
